2) MEETING WITH PERRAN MOON AT HIS PORTREATH SURGERY 11TH OCTOBER.

Love Porteath, although supporting the need for increased flood resilience for Portreath, believe that the current EA scheme does not deliver this for the village as a whole, and has significant negative impacts. A synopsis of our concerns, which we have forwarded to Perran, is below.

SYNOPIS OF CONCERNS REGARDING EA'S FLOOD RESILIENCE SCHEME SENT TO PERRAN MOON.

The current Portreath Flood Defence has one of the biggest maintenance budget spends for the EA in Cornwall. The proposed EA Flood Resilience Scheme which has been presented to parishioners, aims to alleviate flooding in the village. The proposed scheme increases the flow of water through Portreath and on to the beach. To accommodate the increased flow over a significant length the current stream needs to be widened and walls built up to contain the water.

The concerns are as follows:-

- 1) Possibility of sewage flowing through the village
- 2) Risk of flooding to properties previously considered low risk
- 3) Removal of habitats and wildlife.
- 4) Overall visual change to the village.
- 5) Lower water quality due to contaminated water flowing down the valley from the mines and farm runoff.

6) No account for changing sea levels, changing beach level (that could block storm outlet) or high / spring tides in model used.

The proposed scheme is designed for a 1 in 20 year storm event. The scale of the project (11 million), negative impacts and risks involved requires serious reconsideration. Further, the increase in the change in land use due to housing development within the drainage catchment area (Redruth, Carn Brae, Camborne) will increase the risk of flooding even if best practice is followed. When a major storm event occurs the effects will be compounded down stream in Portreath.

We are unable to gain any assurances that SWW will not discharge sewage, they have a
