If you submit comments through the online planning register, all comments will automatically appear on the website. Please try to keep your comments concise and relevant to the policies in the draft Neighbourhood Plan and identify the policy to which any concerns relate.

For the purposes of the General Data Protection Regulation (GDPR) if you wish to comment on a planning application you will be required to read and accept the Privacy Notice for representations (D) on the Council's website <u>Planning privacy notice - Cornwall Council</u> together with the terms and conditions. The Local Government (Access to Information) Act 1985 requires that such correspondence must be made available for inspection either by Councillors or members of the public (which may include the Press).
